Prior knowledge of **Grumpy's of event**

I believe that there are violations of Campaign Finance Laws filed in the **2008 HD 54A Report of Receipts and Expenditures** under **Scheduled B1 Expenditures page 1** and **2008 Citizens for Laliberte Report of Receipts and Expenditures for Principle Campaign Committee**

I will start with the **2008 Citizens for Laliberte Report of Receipts and Expenditures for Principle Campaign Committee** under **Schedule B1-CE Campaign Expenditures**

The first violation deals with the three days prior knowledge of event held at Grumpy's on Thursday October 23 2008 by the Campaign Manager for Mark Laliberte Lisa Belak and Mark Laiberte's Campaign Treasure Don Hewitt who was also the HD 54 Treasurer.

The only notification that I at this time was HD 54A Officer, Executive and Full Committee Member and HD 54A Full Committee Members Reed Skogerboe and my brothers Mike and Bill received came via an e-mail sent out by Mark Laliberte's Campaign Manager Lisa Belak. Lisa Belak is also Mark Lalibete's sister.

I would like you to pay close attention to the title of the e-mail Mark Laiberte's Campaign Manager Lisa Belak sent out:

Free Buffet and Rally for Mark

I believe because this event was never brought up to be discussed by HD 54A Officers, Executive or Full Committees and there never was a vote of approval for this specific expenditure at Grumpy's of **\$1,008.39** it is violation to have it entered been entered **Schedule B1-CE Campaign Expenditures**

Reed Skogerboe my brothers Mike and Bill will all testify they believed this event was put on by Mark Laliberte and not HD 54A.

Moving on to **2008 HD 54A Report of Receipts and Expenditures** under **Scheduled B1 Expenditures** where I believe there is another violation of Campaign Finance Laws involving both the HD 54A Chair Mike Boguszewski and HD 54A Treasurer Don Hewitt.
