Hi Joyce,

Please find the attached information on a violation of the state's campaign regulations, it appears the Candidate Committee responsible is "Wagner (Erin) for Minnesota #18039"

(1) Recording of a radio ad that has been running several times a day on KKIN 94.3 FM for several weeks now without the required disclaimer, recorded about 7:17 AM on Nov. 2, 2016, the ad has been running without a disclaimer since at least mid-October.

(2) A copy of the responsible campaign's website and lack of a radio transcript, copied from the website Nov. 2, 2016 - <http://www.wagnerformn.com/>

Please note that Red Rock Radio stations were recently purchased (Oct 2016) by R & J Broadcasting, the offending ad could be running on many other area stations listed below without the proper disclaimer.
