



House District 34B Special Election Public Disclosure Calendar

- July 11 First day for candidates to sign and file a public subsidy agreement for the special election cycle.
- July 15 First day for candidates to file to run for office. **Candidates must file a statement of economic interest within 14 days after filing for office.**
- July 22 Last day for candidates to file to run for office. Candidates must file by 5 p.m.
- July 23 Last day for candidates to sign and file a public subsidy agreement.
- July 28 Last day to raise contributions, and file an affidavit of contributions, to qualify for public subsidy. The affidavit of contributions includes certain contributions received from January 1, 2024, through July 28, 2025.
- July 29 Last day of transactions to be included in the pre-special primary report.
- July 30 through August 11 **Reporting of Large Contributions – Pre-special primary**
Contributions and loans from any one source totaling more than \$500 must be reported to the Board electronically or in person by the end of the next business day after receipt and also on subsequent reports of receipts and expenditures for the special election cycle. Failure to file the notice on time will result in a \$50 per day late filing fee. **Note:** Candidates who are unopposed at the special primary do not need to report large contributions and loans during this period.
- August 5 **Pre-special primary report of receipts and expenditures due (if there is a special primary).** Period covered: July 11 through July 29, 2025.
- August 6 \$50 per day late filing fee begins for failure to file the pre-special primary report.
- August 12 **SPECIAL PRIMARY** (if necessary)
- September 2 Last day of transactions to be included in the pre-special election report.
- September 3 through September 15 **Reporting of Large Contributions – Pre-special election**
Contributions and loans from any one source totaling more than \$500 must be reported to the Board electronically or in person by the end of the next business day after receipt and also on subsequent reports of receipts and expenditures for the special election cycle. Failure to file the notice on time will result in a \$50 per day late filing fee. **Note:** Candidates who lost the special primary do not need to report large contributions and loans during this period.

- September 9 **Pre-special election report of receipts and expenditures due.** Period covered: July 11 through September 2, 2025.
- September 10 \$50 per day late filing fee begins for failure to file the pre-special election report.
- September 16 **SPECIAL ELECTION**
- October 1 Last day of transactions to be included in the special election cycle final report.
- October 1 Public subsidy agreements expire for the special election cycle.
- October 2 New public subsidy agreements may be signed for 2025-2026 election cycle.
- October 13 **Special election cycle final report of receipts and expenditures due.** Period covered: July 11 through October 1, 2025. **Note:** Candidates will be required to file a 2025 year-end report in addition to the special election cycle final report unless the special election cycle final report is a termination report.
- October 14 \$50 per day late filing fee begins for failure to file the special election cycle final report.
