Dear Senate District 29 Candidate:

The forms and information enclosed in this packet are to assist you in meeting the requirements of Minnesota Statutes, Chapter 10A, which governs campaign finance and disclosure in Minnesota. As a candidate in a special election, you will be required to meet various statutory requirements and deadlines. Please review this letter and the enclosed disclosure calendar for information about deadlines and requirements.

- If you wish to be eligible to receive a subsidy, the enclosed **public subsidy agreement** must be completed and filed with the Board by **August 7, 2025**. You must sign and file an agreement to be eligible to receive a public subsidy payment and to participate in the political contribution refund program. Please read the agreement carefully, because once it is signed, the agreement may not be rescinded.
- The **affidavit of contributions** must be completed and filed with the Board by **August 11, 2025**, if you seek to qualify for a public subsidy payment. The Board will be unable to pay a public subsidy to you if you fail to file the affidavit on time. In order to file the affidavit, you must raise \$3,000 in qualifying individual contributions during the period from January 1, 2024, through August 11, 2025.
- The **statement of economic interest** must be completed and filed with the Board within 14 days after filing for office. A statement of economic interest is required by statute from each candidate filing for state office.
- A **Registration and Statement of Organization** must be completed and filed with the Board by the **earliest** of the following: 1) 14 days after raising or spending more than \$750 (other than your own personal funds) to influence your nomination or election; 2) by the end of the next business day after receiving a contribution or loan in excess of \$500, during the period from August 13, 2025, through August 25, 2025, if you are opposed in the special primary; 3) August 19, 2025, if there will be a special primary and you raised or spent more than \$750 through August 12, 2025 (other than your own personal funds) to influence your nomination or election; 4) by the end of the next business day after receiving a contribution or loan in excess of \$500, during the period from October 22, through November 3, 2025, if you will be on the special election ballot; or 5) October 28, 2025, if you raised or spent more than \$750 through October 21, 2025 (other than your own personal funds) to influence your nomination or election, and you will be on the special election ballot. If you have registered a committee for Senate District 29 and it has not been terminated, you do not need to register again. If needed you may use the enclosed form to amend any committee information previously filed.
- Please refer to the Senate District 29 Special Election Public Disclosure Calendar for important filing dates.

- A candidate is required to file electronic reports that disclose their committee's receipts and expenditures. The Board provides a free web-based application, called Campaign Finance Reporter Online, which satisfies this requirement. Instructions regarding how to begin using the application are available at [cfb.mn.gov/pdf/publications/CFR/Getting\\_started\\_in\\_CFRO.pdf](http://cfb.mn.gov/pdf/publications/CFR/Getting_started_in_CFRO.pdf).

**Late filing fees:** Please note, if a report, including a large contribution notice, is not filed on time, a late filing fee of \$50 per business day will begin to accrue **WITHOUT NOTICE** on the next day following the day the report was due. The maximum late filing fee per report is \$1,000, plus up to 2% of the expenditures or disbursements not timely reported, per day, if more than \$25,000 in expenditures or disbursements were made during the reporting period. The Board may impose additional late filing fees and civil penalties against filers who have incurred late filing fees or civil penalties within the past four years.

**Contribution Limits:** During the special election cycle the contribution limits are as provided in the following chart. Please note, with the exception of contributions from the candidate, contribution limits apply regardless of whether the candidate signs the public subsidy agreement.

#### Terms of Agreement:

As a candidate for the State Senate, I wish to participate in Minnesota's public subsidy system, which consists of a political contribution refund program and a program of direct payments to candidates. I understand that signing this agreement does not guarantee that I will receive direct payments under that portion of the public subsidy system. As a condition of participating in the public subsidy programs, I hereby agree to the following:

1. I and my principal campaign committee will abide by the statutory campaign expenditure limit for a Senate candidate through November 19, 2025. I understand that campaign expenditures include the total of my committee's monetary campaign expenditures, in-kind campaign expenditures, and unpaid campaign expenditures during the special election cycle. The base spending limit for my committee during the special election cycle is \$109,100.
2. I will not contribute to my principal campaign committee more than \$5,000 in total during the special election cycle. I understand that my contribution total includes my cash and in-kind contributions and the outstanding balance of any loans I make to my principal campaign committee.
3. My principal campaign committee will return with its special election cycle final report of receipts and expenditures the amount of public subsidy received (if any) that exceeds my actual campaign expenditures.
4. I and my principal campaign committee will make no independent expenditures.
5. I and my principal campaign committee will comply with Minnesota Statutes section 10A.38, which relates to closed captioning and transcription for deaf and hard-of-hearing persons.

I have read and understand this agreement and I understand that it is a binding legal contract. I know that once I sign and file it, I may not cancel or rescind it even if I do not meet the other requirements to receive direct payments of public subsidy.

### Special Election – Senate District 29

**Why file this agreement.** This agreement must be completed and filed by candidates for state legislative office as a condition of eligibility for the political contribution refund program and the direct payments program of the Minnesota public subsidy system. You may not issue political contribution refund receipts for contributions received before this agreement is signed and filed with the Board. Contributions made prior to the date you file this agreement are NOT eligible for the political contribution refund program.

**You must confirm the filing of this agreement.** An agreement that is lost in the mail or is the subject of a failed or unreceived fax or email is not a filed agreement. After you file this agreement, you must confirm its receipt and filing by the Board. You may do this by checking the candidate information tab on your committee's page on the Board's website, by searching your name at <https://cfb.mn.gov/reports/#/public-subsidy-agreement>, or by calling 651-539-1188.

**Deadline: This agreement must be signed and filed with the Board no later than August 7, 2025.**

#### **Additional requirements to qualify for direct payments of public subsidy**

Signing and filing this public subsidy agreement is just one step in qualifying for direct public subsidy payments. To be eligible to receive direct payments of public subsidy funds you must also:

1. Register a principal campaign committee with the Board and raise at least \$3,000 in monetary contributions from January 1, 2024, through August 11, 2025, from persons eligible to vote in Minnesota. To count a contribution in this total:
  - You must have the name and address of the contributor, no matter how small the contribution;
  - You may count only the first \$50 received from each contributor; and
  - You may not count in-kind contributions.
2. **File, no later than August 11, 2025,** an Affidavit of Contributions verifying that the required amount of qualifying contributions was received. The Affidavit of Contributions may be filed electronically by a candidate using the Board's Campaign Finance Reporter Online application.
3. Be on the November 4, 2025, special election ballot either because you won the special primary or you had no opponent in the special primary. You must also have an opponent at either the primary or special election to qualify for a public subsidy payment.

#### **Spending limit increase for candidates running for office for the first time**

The spending limit is increased by 10% for a candidate who has not previously held the same office, whose name has not previously been on the primary or general election ballot for that office, and who has not in the past 10 years raised or spent more than \$750 to run for any other office whose territory now includes a population that is more than one-third of the population in the territory of the new office. If you meet the above requirements for a spending limit increase, sign the statement of qualification for the first-time candidate campaign expenditure limit increase at the bottom of the public subsidy agreement form.

- Accumulate at least \$3,000 in contributions from individuals eligible to vote in Minnesota, counting only the first \$50 received from each individual contributor. Contributions received on or after January 1, 2024, and no later than August 11, 2025, may be counted toward the \$3,000.
- File an affidavit of contributions with the Board by August 11, 2025, stating that you have accumulated the \$3,000.
- Win the special primary (if contested).
- Have an opponent at either the special primary or special election.
